- \*Minimum purchase of **400** gallons in order to participate.
- \*Gallons are available from the date of your signed contract through April 30, 2022. CV Oil Co, Inc. reserves the right to deliver before or after these dates.
- \*Gallons delivered in excess of the contracted gallons will be billed at the retail price at the time of delivery.
- \*All non-program invoices need to be paid for separately.
- \*CV Oil Co. Inc. does not assume any liability for product run outs.
- \*Customers are responsible for clear access in order to make timely deliveries (snow removal, sanding, vehicles, etc.).
- \*New customers must agree to have a property inspection. This includes oil tank inspections and LP gas inspections with an additional fee.
- \*Customer is committed to the contracted gallons. If there is a BREACH of contract, CV Oil Co. Inc. will charge a penalty of \$100.00 plus \$ .50/gallon for every gallon not used. This serves as authorization to deduct such penalty and fee directly from your credit balance.
- \*Any credit balance will remain on your account for future use unless you request a refund.
- \*The contracted price is excluded from Fuel Assistance benefits. Fuel Assistance price will be determined by the State of VT.
- \*If dramatic events (i.e. Acts of God, terrorism, war, strikes, embargoes, etc.), CV Oil Co. Inc. reserves the right to cancel any or all programs without notice or penalty. Offer stands only if there are gallons available for purchase.
